#### About the Instructor:

Clear and transparent. Improve: Perhaps being able to discuss material more at length (discussion based) although it was difficult due to course material volume being extremely high (length slides).

Enthusiastic, knew what he was talking about. Improve: Lectures tended to be a bit boring at times. However, this may have just been the material and not a reflection of the teacher.

He was very enthusiastic about the course, and he generally had a good grasp of the material. Improve: He was late every class, and then had to keep us over. He handed back our assignments extremely late, without enough time to review it before tests.

Strong: Long office hours before the exam. Improve: Always late, just a few minutes, but...

Provides many good examples, cares about material and wants us to learn. Improve: Presentations aren't very engaging. Sometimes slides are not clear in the point of what they want us to know.

He is very enthusiastic and smart about this subject and just needs to be clearer in presenting what we should know for exams. Improve: Clearer on what we should know.

Very knowledgeable, enthusiastic, and engaging. Improve: Try to reduce the contents of the slides, it's a lot of information to soak in. Try being more concise presenting information.

#### About the Course:

Very exciting and important topic. Improve: Lessen number of slides, increase slide efficiency with more decisiveness on what to include in slides (too all-inclusive and fast to follow all material).

Straightforward, clear, easy to follow. Improve: More interesting examples.

Solid survey of labor economics. Improve: More discussion and more ways to engage in discussion. There was zero class discussion. Even the occasional cold call would have been nice.

Course was thorough, all material was very accessible and teacher was always willing and available to help. Improve: Class is way too long. 6-8:30 is not a good time.

Interesting material with lots of applications. Improve: There is a lot of material in this course that needs to be presented. It's not all difficult but it is explained fairly fast which can make it a tad confusing.

Covered a lot of material. Improve: A little more preparation when presenting and just more clear on some subjects.

Informative, fun, fair, intellectually stimulating. Improve: More on policy, political economy, real world research and less theory.
